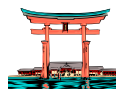

The IPPCA has a program called "Ponditat" for Humanity which allows them to choose a pond that is in need of repair.

Any time a pond is nominated for this project, several things have to be considered such as:

A local contractor must be willing to work with the IPPCA in all aspects including but not limited to coordinating supplies, meals, and lodging. This contractor must be willing to do all this on a volunteered basis and not request reimbursement of any kind for his/her time or his/her company's time.

After considering all the ponds which had been submitted, the Atlanta Scottish Rite Hospital was chosen as the pond as the "Ponditat." This is great news as the hospital serves hundreds if not thousands of seriously ill children each year. The pond is a little oasis in this stressful environment. As David and Mike were leaving from seeing the pond, they observed two sad parents in the parking lot discussing the news they had just received concerning their child. Can anyone imagine how much nicer it would be if they could go sit next to a tranquil pond and talk instead of in the parking lot.

I am hoping that members of the Atlanta Koi Club will provide much in the way of volunteering and we will do what we can to assist with donations. David and I will definitely be a part of both. The dates chosen to work on the pond are July 10th, 11th and 12th. I am

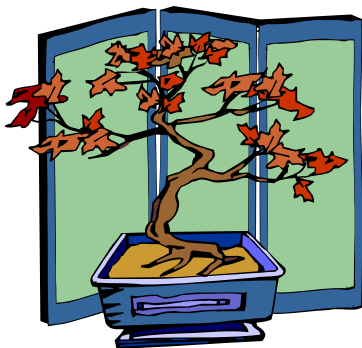

In April the club held a very successful auction! The auction gave club members a chance to thin their respective herds and also gave others a chance to get some great bargains on koi and goldfish. So with the club collecting a percentage of the total sales, it was definitely a win-win-win situation. Much congrats and thanks to the entire event team for that event!!

So for some of us, there is now a little more room in the pond. For all of us, the pond water temperatures are rising from the upper 60s to the 70s. Now is the time to consider a change in the koi food. If you have been feeding them lower protein wheat germ foods, now you can start to mix in higher protein foods. By June the food can be changed to a higher percentage of high protein. Remember as you increase the amount of food, and the level of protein, to monitor the water quality!!!! There is a limit as to how much organic material any pond system can process and still maintain acceptable water quality.

This may also be a time for us to considering adding some new koi. This is where you need to do some serious planning! First thing to plan...your budget. You need to plan for the cost of the fish and also the cost of setting up a quarantine system for 4-6 weeks. Failure to quarantine new fish that puts your entire koi collection at risk. So plan NOW for the holding tank, filtration, aeration, nets and bowls need for the QT process. Note I said nets and bowls. You defeat the purpose of a QT if you move nets, bowls or unwashed hands between the QT system and pond system. Remember to plan the quarantine system to handle the number and size of fish you plan to purchase. While a couple of 4" fish could be quarantined in a 100 gallon stock tank, that will simply not do when it is several 12" fish or one 24" fish. Plan ahead and don't let your eyes overload your quarantine system. Remember the club does have a few soft sided 6' show tanks that can be loaned to members for a few weeks.

Next consider what variety or varieties you want to purchase. Get out your koi books and go over the show classes. In some cases a show class only contains one variety. Examples are : Kohaku, Showa, Sanke, and Bekko. Other show classes can contain several varieties. For example: Hikari Utsuri contains metallic Utsuri and metallic Showa; Kawarigoi is the catch-all class for koi that do not fit in other show classes. So have some idea of what you want before you shop. Also have an idea what makes good specimen of the desired variety



Lastly consider if are you a person who likes to grow out tosai (this year's fish) and nisai (two year old fish) or, do you want the larger (and potentially more expensive) sansai (3 year old), yansai (4 year old) or even gosai (5 year old). The younger the fish the more the risk...but perhaps...the smaller the initial investment. Ultimately you may have to trade off purchasing a smaller fish with greater potential for a larger fish that already may be all it can be. This is part of the fun and excitement of koi keeping.

Wishing you and your existing and new koi every success as you and your nishikigoi step into summer!

Koi Auction Results

As you all know, we had the koi auction last Saturday. I am pleased to say that I thought it was a success. I was cautiously optimistic prior to the event. I really was concerned that we would not get enough bidders to make the event a success. I have to thank everyone involved; it was a team effort for sure. From Bill Fricke arranging the mass of volunteers to Harvey Siskin arranging the AJC article. The auction would not be what it was without these guys as well as all the other volunteers. A big thank you to all. Thanks also to Bill Dowden of **Coastal Pond Supply** for letting us use his facility. Next year should be a breeze for me after having this one under my belt. There are a few operational changes that I will make for next years event to smooth out some of the minor issues that came about during the auction. The books are closed for the event and all the fish/plant owners should have their checks within 5 days.

We had about 300 fish sold, 82 bidders and made a net profit of close to \$3,000. These were the numbers I was looking for. I think all the publicity we had prior to the event increased the foot traffic significantly. We also signed up a few new members and had a lot of inquiry about the club.

I had a lot of fun answering the AJC questions during Katie's interview. It was sort of funny after the article was published; I received e-mails from people I had not heard from in 10 years. The funniest thing was I recently got my hair cut and as soon as I set foot in the barbershop, my barber said he read the article and said I was a famous koi keeper. I had to laugh. I thought I would include in this article the questions that were asked from the AJC reporter and my answers. Hope you enjoy.

Q. Why does the koi club host an annual auction?

A. The Atlanta Koi Club holds an annual auction for its members so that we can "thin the herd" so to speak and make room for new wet pets. For me, the hobby has evolved from a nuts and bolts approach building my pond to a true appreciation of the species. My appreciation has grown to include trips to Japan to hand pick koi and import back to the USA to inhabit my pond. It is quit important that the population of koi within any given closed loop filtration system (namely a pond) be equal to the capacity of the filtration system. If not, the water quality will suffer and the koi will eventually get sick and die. So hence the need to thin the heard. I use the rule of thumb that translates to one full grown koi per 1000 gallons of well filtered water. The auction allows members to sell their koi, enabling them to go to good homes where they will be well cared for. The club is a non profit organization and it is hard for us to sustain existence without a supplement so we require a small percentage of the sale to go back to the club to help fund its events. The Atlanta Koi Club is dedicated to sharing the joy of koi keeping www.atlantakoiclub.org. We are an open group that holds monthly meetings that anyone can attend. Our goal is to educate and inform people, detailing the proper methods and procedures, for the care our koi

Q. Do you have to be a member to attend the auction? Or have koi to trade?

A. No, one does not need to be a member in order to attend the auction. The event is open to the public and we encourage people outside the club to attend. One does need to be a member in order to auction their koi. This event is another way that the club can educate people about the hobby and promote its membership. The auction is also set-up so that members can sell used equipment and plants.

Q. When did you begin raising koi, and what do you enjoy about it?

A. I started this hobby about 8 years ago. My father had a small koi pond growing up back in Connecticut. I watched him take care of his koi and tend to his bonsai. I had always wanted to share his passion so after I got married and started to raise my family, I built my first pond.

There are so many aspects of this hobby that are both enjoyable and rewarding. I for one get great pleasure from sitting and watching my koi swim. They are truly creatures of beauty and grace. I guess the most enjoyment I get is when I can take my young boys out to the pond, let them sit on the pond wall with their feet in the water and watch them giggle and tell me which koi is their favorite and why.

Q. How large is your koi pond, and how much time per week do you devote to the hobby?

A. My pond is approximately 12,000 gallons which includes my filtration equipment. Its funny that you ask how much time I spend devoting to the hobby. I am an automation Engineer and designed my pond to be almost totally automatic. After I researched for about a year on the proper methods and procedures for building my pond, I decided to add my own take on the process of filtration. I have two PLC's (Programmable Logic Controllers) that actually run my pond. The equipment that I designed is geared towards low or no maintenance and is automated. I decided right from the beginning that I did not want to spend hours maintaining my pond. I needed a way to reduce the maintenance thus enabling me to spend more time with my family enjoying the koi. So to answer your question, I can get what I need done to maintain my pond in about an hour a week. I have also pulled all my information together over the past 8 years and started a non commercial website so that others can have access to my information. The website is located at www.koipondfiltration.com

Q. How has the drought affected people with koi ponds?

A. These times of draught really influence how the typical pond keeper maintain their pets. In addition, the new pond must be planned in order to minimize the impact on the environment. Good husbandry skills are required to keep koi healthy. In the past, changing out some of the pond water on a weekly basis was practiced. This technique is not new to keeping fish in a closed loop recirculation system. Many home aquariums practice this as well. Unfortunately water usage in the Atlanta metro and surrounding counties has been restricted due to the lack of rain. For these reasons, the club and members agree that water conservation is its top priority. Information on alternative techniques to maintain water quality are discussed on a routine basis. The club 's desire is to be a leader when it comes to water conservation and not a follower.

It is imperative if one is planning a new pond to take into consideration water conservation. If carefully planned ahead of time, the impact on the environment can be minimal. It is obvious that any new pond construction project be approved by the local city or county government. Just like with the requirements on new pools last year, purchasing water from out of state contractors can be employed for the initial fill of the pond. Once the pond is up and running, there are supplements that can be added to the water to keep the mineral and chemical composition in balance. The addition of supplements is another method to enable water conservation.

Q. What would you tell someone interested in having a koi pond?

A. Do your research, build the pond right the first time and join a local koi club. The local koi club is the best way to get educated on "Sharing The Joy Of Koi Keeping".

I wish it were possible to see every koi we're called about and to save every koi we see, and although I don't like it, I recognize that just isn't realistic. However, with the new blood from our three candidates and mol, the club really has great coverage for pond and health issues. *Thanks again to the club and the Brown's scholarship for making this financially doable for the four of us.*

Finances

Please remember that we are volunteers and do this without thought of being paid for our time... Please don't offer, none of us would look good in stripes. In fact, under the GA law we cannot accept money for the work we do. You can defray our costs however.

With gas at over \$3.50 a gallon, I have to go by the bank for a loan on my way from Powder Springs to say Conyers. I

actually put 14,000 miles on my Sport Trak last year making pond calls (so that adds wear and tear). **Mileage** makes more sense than just gas money.

We have **expendable supplies** we use. These don't amount to much but over a year add up. Offer to replace what we use so we are ready for the next Pond call.

There is an unbelievable amount of **laboratory and field equipment** that we need to offer you the help you require. The scholarship got us to certification and pays for our microscope and water quality tests kits, but there is so much more needed. You can best thank us by offering to buy and donate some of that equipment.

Some Caveats

There are also things you need to understand.

Fish medicine is extremely challenging... we don't have the tools and sophistication of people medicine, and fish are just plain hard to work with, much more so than small animals. **If we advise that relatively inexpensive tests are needed, it's your ultimate decision, but if you decline the test we may simply not be able to help you further without that information.**

We take pains to inform you of everything we see and advise you on a course of action. **You have the right to choose a different course of action;** but please understand that when you choose that course, **you have also effectively rendered us ineffective** and in reality wasted our time of which there is never enough. **Don't be offended should we choose to use that time to help those who will follow that specific course of action.**

We love what we do and enjoy the hobby immensely, but when we come to the pond we need **to focus on the problem, get the job done and move to the next challenge.** Some will have a better "pond-side manner" than others, but our job is first to heal your pond/koi problems, then to help you become better koi keepers through teaching you new approaches. **We socialize at meetings and over drinks in the evenings after we've done our day jobs and made a pond call or two.**

Don't withhold information out of embarrassment. We are not in this to judge. Nothing in the course teaches jurisprudence. We are koi keepers first and KHAs second **and each of us have seen and often made every mistake that one could make.** That is always in the past. We can learn from the past, but we can't change that reality and we won't try. I've killed my own fish out of stupidity...so you would be hard pressed to top that.

Necropsies

Necropsies are how we are able to tell you how to protect your surviving koi. The only really effective koi for necropsy is one that is moribund (dying) that we can euthanize and examine immediately after death. The reason for this is that koi tissue deteriorates extremely rapidly. So **call us early, before you lose this valuable diagnostic tool.**

Somewhat useful is a fish that is chilled immediately (within 30 minutes) of death. Double bag the koi (without water inside bag) and chill in refrigerator or cooler and call one of us. **We need to get the fish within hours, however.**

Necropsies are also how we learn to identify normal and abnormal. So if you lose a fish over 12", please call us so we don't also lose a valuable learning tool.

Thanks for the listen and join me at the next meeting in congratulating our 3 KHA candidates. They have the tools they need and are ready and willing to help. **As candidates they have the tools to start helping you today. Help them in gaining that experience base that will prepare them for the inevitable emergency you may face with your pond or your finned friends.**

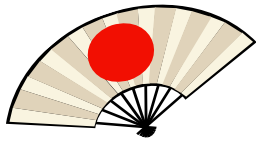

Vicki (Vaughan) and Carl (Keirin Koi) Forss have invited us to have the May meeting hosted by KOILAB at their Flat Rock Road farm in Watkinsville, GA (directions p. 10).

Vicki and Carl were recently in Japan and have returned with a variety of koi. Specifically they brought back Shiro Utsuris with the club members in mind. Many of you are aware that this is a very challenging fish to pick because you have to have an "eye" to see the potential sumi. You may find this a fun grow out project because of the dramatic changes the fish will undergo as it ages. The shiro utsuri breeder is Omosako near Hiroshima. While at another breeder's, Momotaro's, they called to request an appointment to pick fish in the morning. They were offered an afternoon appointment instead. Assuming that they had another buyer that morning and they proceeded to travel by train to the Omosako greenhouses the next afternoon. Upon arrival, they realized that the appointment had been pushed back so that the elder Omosako could pick through several thousand tosai to get 50 of his most promising tategoi for us. He also tried to pick female and felt that this batch was 80% female. Originally the plan had been to get smaller fish, but plans change. Besides to have refused these fish would have been a slap in the face. Their good fortune has resulted in the opportunity for club members to pick from some of the best young Shiro Utsuris from Japan.

If the weather permits they are planning to pull a mud pond to get the huge brood stock females out for breeding.

Other changes have occurred since the clubs visit last August. They have built a new building to house fish, are also adding a nursery section which will feature water plants, Japanese maples and some native plants, and finally one more temptation is they will have available for purchase Tomosaba goldfish from Koneco Koi Farms in Nigata. They are bright red and pure white.

Fun additions to the farm strictly for viewing are exotic chickens and giant Flemish rabbits. Just for fun Google "world's largest rabbit" and check out Herman, who lives in Germany and is the same breed.
