Ask the Experts

Question

When using potassium permanganate, hydrogen peroxide is supposed to be used afterward to neutralize the PP. But, if my first dose of PP produces a brown color, and the purple color disappears, does that mean the PP is used up? Do I still have to use hydrogen peroxide in that case?

Reply

PP far too broad a subject to use like this in the newsletter.

To answer your question, why would you not neutralize? Sodium thiosulphate is very cheap and makes sure the PP has stopped all oxidation. Yes if the PP has completely expended itself then you are correct that you don't need to neutralize, but I do anyway. Then I follow with the H2O2 to make the water crystal clear. That being said, I don't use H2O2 to neutralize PP. It Causes a severe drop in ORP, which is not good for your fish. I use Sodium thiosuphate to neutralize chlorine. It also works well to neutralize PP, and a little while later I use the hydrogen peroxide to clear the water of the brown stain that PP leaves behind. Hydrogen Peroxide has to be dosed just like any other med. Too much will definitely harm your fish. It is an oxidizer also.

Items for Sale by Members

Three half-sheets (24" x 39" x 1.5") of Matala Black Matting (<u>http://www.matala.com.tw/biomedia/matala_filter-media.html</u>). The matting has an approximate surface area of 46 square feet per cubic foot. The matting makes an excellent mechanical stage filter. Single sheet = \$25. Two sheets = \$47.50. Three sheets = \$65.

Eight cubic feet of Cermedia MarinePure 2" Cubes (MP2C) (<u>http://www.cermedia.com/marinepure-technical.php</u>). Cermedia MP2C has a massive surface area per cube making it an excellent nitrification media. Each cubic foot can perform bio filtration (nitrification) for over 1,000 gallons of pond water. Eight cubic feet will handle at least 10,000 gallons.

Single box of two cubic feet = 225. Two boxes (4 cubic feet) = 425. Three boxes (6 cubic feet) = 825. Four boxes (8 cubic feet) = 800

Auction 2016 Information

There seems to be some confusion over the auction rules that need clarification prior to the 2016 auction. From the rules on the web site:

Who can sell?

The auction is open to active members who wish to cull their ponds: either individual members or household memberships. There is a limit of one seller per household. Active members are classified as those who attend 5 or more meetings in a year or have volunteered for 3 or more Club events within the past year. Members who meet combinations of these requirements will also be classified as active per the Membership and Auction Chairs' discretion. Membership must be current and the Membership Chair will determine eligibility of members who wish to participate. Members who do not meet the above requirements will be considered non-active. Non-active members will be able to auction fish at a reduced percentage. Non-members will not be able to have fish auctioned or sold. Percentage of Sales

All sales are divided into the following classifications. Active members will receive 75% of any sale with 25% of any sale going to the club. Non-active members will receive 50% of any sale with 50% of any sale going to the club. Active members who need assistance from the club catching and transporting fish will be required to use the 50/50 split classification. Non-active members who need assistance from the club catching and transporting fish will be required to use the 50/50 split classification. Non-active members who need assistance from the club catching and transporting fish will be required to use a 25/75 classification. 25% of any sale will go to the member and 75% will go to the club. All sales are final, no refunds are available.

By Law Amendments

The amendments to the bylaws were passed by a voice vote after discussion. They are

Amendment 1

Newsletter advertisements will be limited to the sale and/or trading of voting member owned koi, pond, or koi club related items.

Amendment 2

Members will be given the option to "opt in" enabling the club to share their email address with selected sponsors for commercial purposes related to club activity.

Amendment 3

Contents of the Atlanta Koi Club social media site(s) falls under the auspices of the executive committee or their appointees, who will determine the appropriateness of any posting. The club may elect to allow postings which include the sale and/ or trading of koi, pond, or koi industry related items by sponsors and members. However, the use of the Atlanta Koi Club social media site for the purpose of advertising a koi industry related business is restricted to sponsors.

AKC Facebook Page

Diane and Julie Melancon will be the default administrators for the Facebook page and the club will revert back to the original page dropping the non-profit page since this page does not support the sending of automatic update notices to all followers.

Koi and Goldfish Show

The event will take place at the Gwinnett Fairgrounds from October 9 - 11, 2015. It will be an indoor event.

- The Gwinnett County Master Gardeners will host a plant sale on October 10 as a part of the show.
 - The Hilton Garden Inn has been selected as the host hotel offering discounted room rates, a shuttle to the show venue, a discounted breakfast and hosting the Saturday evening awards banquet.
 - The show will feature wet and dry vendors, judging of koi and goldfish, raffles and seminars. The Friday night Vendor Appreciation event will take place on October 9th starting at 6:30 pm giving members a chance to visit the vendors and meet the judges while enjoying a selection of free food and beverages.

Trophy sponsors are still needed. You receive one free banquet ticket for each \$100 in trophies you sponsor.

Members are encouraged to recommend dry vendors to the show chair persons.

Be sure to check the club website often for show updates.

Pond Tour

Melanie updated the executive committee on the Pond Tour and made recommendations for the next tour.

Move back to an annual pond tour schedule with ponds selected by location (maybe East and West metro)

There is a need to review the logistics for ticket distribution.

Consider tickets at selected ponds on the tour

Be ready to sell tickets if the club participates in the South Eastern Flower Show 2016 if it is held

Executive committee voted to contribute \$500 to Children's Hospital this year and 25% of pond tour profit to a charity of the chairperson's choosing the following years.

Melanie noted that the club website is not a responsive design. This means that phones, tablets and phablets are not well supported. A request was made to investigate a website redesign. David Marier is investigating.

Credit Card Handling

David Marier is investigating the cost to change vendors.

2015 Elections

Diane will designate an election committee with the plan of holding the election at the Fall Social in November.
