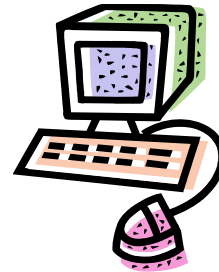

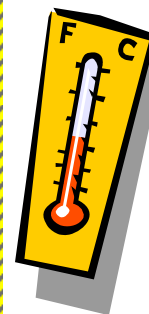

## Thought My Pond Was All Female

I have been doing this pond thing for going on 9 years now. I had a plan way back when. Build the pond, filter it good and see how it goes. Started like all, buying low end koi and having fun seeing them grow. After about 3 years, this was not enough. I fine tuned my pond, added high end filtration: RDF, moving bed K1, Bakki shower and auto-make up water.

After the new pond syndrome was over, I started to settle into this hobby (obsession). At one time I had over 30 in my 12,000 gallon pond. Thank God for the AKC koi auction. This year I am down to 16. Over the last few years I started to thin the herd removing the mutts and male koi. Kind of thought I had all female koi left. I never had a spawn in all the years of doing this. This year I realized that 4 out of the 16 are male.



It was the day of the pond tour. All hell broke loose, a pond full of foam, loss of scales thrashing and pure mayhem. I was a bit confused and upset but I soon thought what if. The 16 koi in my pond are all imports and I consider them above average. Maybe it was me but I was hopeful that the loss of scales and abuse would not be in vein. So I let them eat the eggs and thought that the strong and/or lucky would survive. That's what I wanted anyway. Who wants a few hundred trash koi. What would you do with them all? Who would be left? Would any turn out to be up to my standard? It was a waiting game

of sorts.

My large 30" female Shusui was chased by Mr. Showa, Mr. Gin Matsuba, Mr. Ochiba and Mr. Sanke. I was amazed at the size of the eggs. This female is big and has one of the best body conformations of all the koi in the pond. Out of the thousand or so eggs laid, all were eaten except a few.



I counted about 15 baby koi today. Looking close, there are 4-5 that really caught my eye. It's amazing to see their growth and they all take after their mother. At this young age, they are big boned and busty. Like I said, a few have great patterns to match the body, the rest will be nice and sold at auction in a year or two. The best is a Showa that likes to hide in the rocks. When I get a glimpse of him/her, I say to myself, maybe I should keep a few of the males around for the fun of it all. Who knows, this may be another chapter in the Castel pond journey.

Sometimes I think I tend to use koi & goldfish shows as an excuse to travel and visit good friends, but winning something is always nice, too. Carl also enjoys getting away to spend time with fellow fishy aficionados. When traveling to far off events car pooling can really cut expenses and ease the boredom of driving by taking turns behind the wheel, thus Gaye Jones usually offers her huge Denali for transport if we are not taking the RV.

This year's shows started off in May with a road trip to the koi & goldfish show in Warner Robins GA hosted by the Middle Georgia Koi Society. We took our RV complete with Poodles and a Schnauzer. Being able to camp out right on site was a great convenience and the club members were the friendliest you could ever meet. For a first time show they did an excellent job under the guidance of Bart Atkinson, I was able to help out by benching all the goldfish entries in the show for Judge and Goldfish Guru Peter Ponzio. My koi did well as did my long fins winning Best Long Fin A & B. But it was my goldfish that did the best when my red and white Telescope was awarded Grand Champion. This particular goldfish I bought 2 years ago at the show in Chicago and grew it out from a small under 3 inch fish. My blue Ranchu also was awarded the AGA Judges Award.



The next show on the calendar was the Louisville Koi & Goldfish Show as always on Memorial Day Weekend. Unfortunately Carl had to work so Gaye & I loaded up the Denali with goldfish (I left the spawning koi at home), little dogs, and headed to one of our favorite shows.



Again I was able to lend a helping hand to the club by benching the goldfish entries for Bay Bateman to judge. Now, I have to say that every year this show has by far the best banquet food of all the shows because it is a smorgasbord of dishes prepared by the club members. If you're on a diet... beware.

This time Gaye won top honors with her Ranchu taking Grand Champion and her Ryukin receiving the AGA Judges Award. Good job Gaye! One of my goldfish won Most Unique, at least I think it was for the fish. We went with AKC Friendship Awards. For koi we chose a stunning Gin Rin Kohaku which we later found was owned by Dick and Brenda Thomas. This koi also earned the club's AKCA Award. Dick is the President of NMZNA out of Indianapolis for whom I had the privilege to judge the goldfish show last year and you could never meet a nicer couple and good friends. For goldfish we presented the award to Jan Thompson one of the koi judges for her Jikin. Jikins are quite rare and this was the first time either Gaye or I had seen a real one.

In July Carl & I packed into the Denali and headed to Chicago with Gaye. The Midwest Pond & Koi Society was also the site of the American Goldfish Association Annual Seminar & meeting which pushed goldfish entries over 100 to almost match that of koi. Judging goldfish was Art Lembke who was shadowed by his wife and Candidate judge Nichole. Both Art and Nichole went on to judge koi with Jan Thompson. This time the goldfish Grand Champion was won by Bay Bateman's Ryukin and Gaye won Baby Grand Champion with a Ranchu and was again awarded the AGA Judge's Award for her Oranda. This Grand Champion win made Bay a multiple GC owner therefore to mark the occasion Steve Childers stepped up and announced that as a result of her multiple wins Bay joins the elite "Royal Order of the Red Heads Sorority". Bay was then fitted with a red wig to take her rightful place in the sorority. MPKS always has a
