For those of you who volunteer at the show we will have a raffle for a fish again this year. The fish we are using this year is a nice kujaku to sai that Jerry purchased at The Koi Store and hadn't picked up yet. The fish has been put in the mud so it will get some nice growth before the show. The Koi Store will bring the fish to the show and place in their dealer tank to be entered in the show. The show Sign Up Genius will show how many tickets you get for each volunteer position you fill – it will be noted as 1RT, 2 RT, etc. where 1RT = 1 raffle ticket. 

Quarantine Procedure for Fish

Erik L Johnson DVM (from September, 1995)

Quarantine is the best method to reduce disease introductions. Let me outline a quarantine facility and protocol as if the fish we were discussing were quite valuable. First, a large facility is required, 100-150 gallons is good.

It should have a fully cycled filter sponge or other type of effective nitrification system, fully operational. A quarantine with bad water is infinitely worse than no quarantine at all.

Temperature should be 78 degrees in quarantine.

pH should be supported with neutral buffer dosed according to label instructions.

You should dose the quarantine with 0.3% salt (Non-iodized salt at 3 teaspoons per gallon).

The quarantine should be completely covered because they like to jump out, and that can be costly.

You should check Ammonia and pH in quarantine each day. Ammonia should be ZERO.

You should feed an antibiotic food during the stay in quarantine.

The facility can be safely treated with Dimilin while in quarantine, even with the salt, etc. This will stop the introduction of Lerneiid and Branchiurian parasites.

Finally, the quarantine should be of a 14-21 day duration, so long as water quality can be supported with changes, etc. as needed.

Details:

If you purchase a fish from a pond you can elect to it put back in the mud until the weekend of November 18th. This will give 12 more weeks of growth at a lower stocking density. There will be a charge of \$50 if your koi goes back in the mud.

If you purchase a fish from a pond and don't want it to go back in the mud, there are 2 options.

First, all fish pulled from the mud will go through The Koi Store's clean up protocol. After that you can either pick up your fish at The Koi Store or they will bring it to the show and you can take it home from there. If the koi is brought to the show it can be entered in to The Koi Store's dealer tank for judging.

It is always a fun day at The Koi Store. If you want to bring something, dessert would be good. Also, although not required, as RSVP would be nice so they can plan for lunch accordingly. Please RSVP by replying to this email.

Remember: Good tip from AZ Ponds

Every process that happens in the pond is dependent on oxygen. This is especially important at night when plants are not converting CO2 into oxygen. Dissolved oxygen levels are also generally lower in warmer water temperatures. Pond aerators oxygenate your pond, helping all biological processes and creating a more stable environment, resulting in healthier fish and plants.

Koi Varieties - Simplified

by John Nichols, AKC Show Chairman 1995

The following article is intended to help you classify your fish for the show

1. Kohaku - Red markings on a white background.
2. Taisho Sanke - Red and black markings on a white background. There should be no black on the head. Normally no black is below the lateral line except black may appear on the fins.
3. Showa Sanshoku - Red and black markings on a black background. Black should appear on head and below lateral line and on fins.
4. Utsurimono - White, red, or yellow markings on a black background. Black should appear on head and below lateral line and on fins. (A Showa with black and only one other color).
5. Bekko - Black markings on a white, red, or yellow background. There should be no black on the head. Normally no black is below the lateral line except black may appear on the fins.
6. Asagi! Shusui: Asagi - the back is blue with each scale outlined in white giving a net like pattern. The light blue head should have no markings. The stomach, base of pectoral fins and around the gills should be deep orange or red. Shusui - a doitsu Asagi. Scales appear on the dorsal and may appear on the lateral line but koi is otherwise scaleless.
7. Koromo - The red pattern is overlapped with a black or blue pattern. Reticulated scales appear on the red markings
8. Tancho - A red pattern appears on the head but nowhere else on the body.
9. Hikari-Muji - A single-colored metallic koi with no markings. Includes Matsuba or pine cone patterned koi.
10. Hikari-Utsurimono - A metallic koi with a black (Utsurimono or Showa) background.
11. Hikari-Moyo - A metallic koi other than a Hikari-Muji or a Hikari-Utsurimono.
12. Ginrin - The individual scales, or some of them, have a gold or silvery sparkle.
13. Kawarimono - All normal-finned koi that do not fit into any of the above categories.
14. Butterfly - Any koi with unusually large fins. Note: These are guidelines, highly simplified, and there are exceptions.
