David then introduced Gary Montalto to present the results of the Koi Club Survey. Gary thanks all who worked on the survey with special thanks to Herve for all his help. A synopsis of the results of the survey will be posted on the website.

Susan Brown, Membership Chairperson welcomed new members Mike and Phyllis Loudermilk and new sponsor Mihoko Chambers from ReMax Home Sales who offered to make a donation to the club for every house that she sells from a club referral.

Susan will be ordering Atlanta Koi Club decals for all members and sponsors. Two per family will be provided at no cost and additional decal can be purchased at \$5.00 per decal. Susan will also be selling Koi Show pins at our monthly meetings

Pond Tour Chairperson David Pugh requested that all pond descriptions be submitted to David by February 22<sup>nd</sup>.

Treasurer Ron Scott reported that he has received notification that the Atlanta Koi Club has been approved for nonprofit status. The status was approved to be backdated to September 20<sup>th</sup> 1990 and the club does not owe any back taxes. Ron is in the process of filing tax returns.

Ron also reported that the club's checking and saving accounts have been changed from Bank of America to BB&T. This change will save the club backing fees. At present the club has a balance of \$19,000 in our savings account and \$1,900 in our checking account.

Herve Rijneveld, Property Manager reported that he has been unable to acquire the trailer registration from Smokey Sullins and will try to arrange a time to pick it up.

Herve also announced that the club will sell all of our soft shell tanks. The proceeds from the sale will help to defray the costs of purchasing our new hard tanks. Club members will have first choice at purchasing the tanks. The cost of the tanks will be \$250 for the 6 foot 450 gallon tanks and \$300 for the 8 foot 750 gallon tanks. A sign-up sheet will be at the meetings. **The deadline for payment of these tanks will be April 15<sup>th</sup>.** The unsold tanks will be sold to Susan Reed of the North Carolina club.

# What Is Your Pond's Magic Number?

PPM stands for parts per million. It is a ratio, not a specific amount. Examples are: one pound in a million pounds, two ounces in two million ounces, three grams in three million grams, etc.

OK, but what does this have to with our nishikigoi ponds? The reason for understanding PPM is that many information sources will give pond treatments in PPM. It is then up to the pond owner to

know the volume of their pond system and then calculate the grams (if dry) or liters (if liquid) of the chemical that are needed. Why all this talk about metric? Because it a more accurate measuring system that our old English system. Also, metric is the measurement standard system used in medicine.

The keys to using PPM are:

- Know your pond system water volume in US gallons
- Convert the US gallons to liters (multiply gallons by 3.7834)
- Divide the total liters by 1000 this is your pond's "magic number"
- For dry chemicals, multiple "magic number" times specified PPM dosing rate to find the total number of grams needed
- For liquid chemicals, multiple "magic number" times specified PPM dosing rate to find the total number of milliliters needed
- Use a gram scale (from the kitchen department of a Super Store) to measure the dry chemicals
- Use a glass measuring cup's metric scale to measure the liquid chemicals

Some quick examples: Our pond is 10,000 gallons or 37,834 liters. We divide that by 1,000 to get 37.834 as our pond's "magic number". We need to dose a dry chemical at 2PPM. We multiple the "magic number" by 2 and get 75.668 grams. Many weeks later we need to dose the same pond with a liquid chemical at 25 PPM. This time we multiple the "magic number" by 25 to get 945.85 milliliters.

What is your pond's "magic number"?

### It's a 3-fer Show!

Our 2007 koi show is already in the planning stages. With that in mind, I thought you needed to know about some of the new standards for showing fish.

Before 2006 — there were only standards for judging nishikigoi in a koi show. Goldfish were not there, and certainly those long-finned koi were left back in the pond. Things began to change. More and more goldfish were included in shows to add another dimension to the fish show experience. Goldfish standards were decided by a national organization. When shows began adding long-finned koi to the show list, a problem arose. How do you judge long-finned koi? Much as we may love them ... they are just not the same as regular finned koi. Long-fins are often longer and leaner than their short-finned counterparts. Their fins are not "standard" by any means. After a lot of discussion with breeders and judges, AKCA developed standards for judging long-finned koi. An article appeared in the Nov./Dec. issue of KoiUSA detailing the standards. With Ray Jordan's permission, I am condensing this article to share with you.

- 1. Body Shape: Finnage and Deportment outweighs all other standards combined ! Long-fins should have NO missing or deformed fins, barbels, eves or other body parts. Pompoms and longer barbels — if balanced —are acceptable. Strong body conformation and fins which allow effortless movement give the fish the best impression.
- 2. Color Colors should appear thick and uniform with the same hue all over the body. Pattern edges should be sharp and colors should not bleed into one another. Speckling is undesirable.
- 3. Pattern Long-fins should display the same type of desirable pattern characteristics already standardized for regular koi. A kohaku with long fins should look the same as a standard kohaku except for the graceful fins. Because long-fins have longer, thinner bodies, it is wise to avoid patterns which make them look longer. Wrap around designs accentuate the positive aspects of long-fins.
- 4. Overall Appearance / Elegance Higher quality long-fins have a "luster" produced by youthful looking skin and a healthy sheen which really makes the color pop. The best fish will be graceful swimmers with fins neither too long or too short and elegantly displayed as they swim effortlessly around their tank.

I also asked Steve Childers for comments or suggestions about showing fish. He added this information:

My only suggestion on education would be for the membership to limit their entries to the top 1 or 2 koi/ goldfish/long-fin for a variety/size. Someone who brings 10 long-fins the same size is putting themselves and their fish through undue added stress. Also, I would suggest that they enter them on Friday evening if at all possible so as to give time for adjustment to the show water and such...it's easier on the fish and allows for smoother registration. 
#### **AKCA Seminar Attendance Pins**

# A Glimpse Into UGA's Koi Health Management Seminar 2007

We have to thank Bart and Kathy Atkinson. I'm sure they didn't know it when they brought their large koi to the Koi Health Management Seminar for "free consultation" that they would offer the rest of us a valuable experience in return. The gorgeous showa from Japan was to be anesthetized so blood could be drawn to determine KHV status before allowing the fish to enter their pond.

This is an important lesson to all hobbyists. After six month quarantine, Bart and Kathy brought the fish to the veterinarians to draw blood for the all-important final fate of this fish. The act alone shows fortitude and priority not readily available to most hobbyists, to put their expensive koi into the hands of a blood test. If the tests show no KHV antibodies, the fish will remain in the family to enter their pond. If there is a positive result to the tests, which will rule out any chance of error, the fish has two choices: euthanasia or heat treatment. Either way, it can never be kept with normal, KHV-free fish if the test is positive. Ideally, the fish would be put down to prevent any chance of contaminating other stock in the future.

If no testing were done, the fish would still have a 50/50 chance of having KHV. Is it better not to test the fish – a simple blood test which is accurate and inexpensive – and possibly lose every fish in the pond? Anybody who is not quarantining fish is risking disease, but they are still not ruling out KHV by a mere quarantine. Do a blood test. Have your veterinarian take the blood for you if you are not comfortable or do not know how to do this yourself. Call Vicki Vaughan. Then send it to the Koi Lab at the University of Georgia, attention Vicki Vaughan.

What the attendants at the training seminar gained from this experience was to witness trained veterinarians collecting blood. We learned that MS222 (or any anesthesia) is not as effective in cold water temperatures. The fish simply did not want to go to sleep. It seemed to take forever while the group stood around watching, waiting, with syringes and test tubes. A centrifuge sat near the building, plugged in and ready for the 10-minute preparation to separate out the serum from the blood. We saw how difficult it can be to find the vein, even if you are an expert. Now we know. We gained knowledge and confidence from this valuable experience.

Next, they brought another fish, a large female that had stopped feeding and was basically sitting on the bottom by herself. She started to gain weight through her mid-section last summer. We thought it might be a tumor. She was in a female-only pond so there was no breeding. Dr. Stephen Hernandez-Divers did an Endoscopy on the fish, with a projection screen for all to watch. He first entered through the gills to check for disease and found everything fairly normal. Then he made an incision (with scissors) into the abdomen and put the Endoscopy into the body of the fish. It was spell-binding to watch as he probed his way through the koi's system. There was no tumor. There was nothing but eggs. This fish had been unable to discharge her eggs and they were becoming calcified. She was extremely fortunate that Bart and Kathy brought her in when they did, before it became septic. As it happens, Dr. Hernandez-Divers and Dr. Erik Johnson have made a date to remove the eggs and spay the fish. She will live and we were all there to witness it.

And Kathy and Bart probably just thought they were getting free assistance. Thank you, Bart and Kathy for what you gave to us! We can never repay you...

There were other volunteers at UGA's seminar. Every veterinarian, professor and microbiologist, and even Carl Forss, were there on their own time and pocketbook to teach others how to better care for their fish. Retailers will be better able to protect themselves and their customers from KHV and hobbyists will know how to double-check the health of their fish, and treat when needed. The money invested was well-spent – on our food (which was superb!) and laboratory expenses and such. Michael and Toni Anderson are always there to volunteer their services as "Vicki's Posse" in whatever is needed to make the weekend a success. Vicki was there and we all know how much pain she was in, but



that didn't slow her down. Carl was his ever-present, everwilling, dedicated self, doing all the behind-the-scenes work to make such an enterprise happen. All I did was show up for the miracle. These people handed it to me. Thank you. And thank you to my employer who volunteered the products to hand out to all who attended; we all know how prestigious Microbe-Lift has become, so you got something else of real value. I'm proud to work there and grateful to have met the fine people at this seminar. I hope to do this again next year. [Editor's note: 3 AKC members were attendees at this year's conference— Bart & Kathy Atkinson and Harold Biggio. Congratulations!]



## Aeromonas Alley

Winter arrived in Georgia a little late this year. We have now seen our nightly temperatures dip to the upper teens and low 20's. Once the temps hit 45 degree F, our little fishes went into a condition of *Torpor*. (They just are not moving very much).

Webster's says *torpor* is a condition of mental or physical inactivity or insensibility; lethargy or apathy. "Many of the people I am forced to work with are in a state of *torpor*."

Harold and I discussed what the next article should be and we agreed that we should remind everyone that the next possible cold water problem that we may encounter is that ugly rise of "Aeromonas and Pseudomonas" and the problems they might bring us. (So y'all watch out now, ya here?)

If one discusses Aeromonas, Pseudomonas needs to be lumped into the discussion as well. These pathogenic bacteria are the primary cause of all ulcer disease, fin rot, and mouth rot. That's right, ALL.

Although they can do the above damage, they have a primary and good function and that is to breakdown fish feces; their favorite snack However, if one of our little fishes has a wound from a rock, a nibble of skin that has been taken out by a parasite, or a bump on the nose from foraging, the Aeromonas will attack those open sores. They are very opportunistic and will take the easy road to fresh food.

Let's think of these bugs like we think of cold or flu germs that could affect yours or my immune system. They (germs and aeromonas) are with us all the time, ever present, always a threat, but only attack us when we lack the ability to fight them off.

Richard E. Carlson, AKCA, teaches us that the Aeromonas activity levels and the Koi's immune system are directly tied to our pond's water temperature. These temperatures or "Magic Numbers" are guides for us to follow for everything we do with our fishes and the ponds themselves. If we are aware of this temperature connection then we can be ready to prevent or catch problems as early as possible. For example, don't feed until a certain temperature is reached, the temperature that has an effect or lack of in some cases on medical treatments, and temperatures when our fishes are most likely to get diseases.

We will refer to those temperatures as "**Aeromonas Alley**". The temperature range where we can expect problems to pop up. "**Aeromonas Alley**" is when the ponds temperature is between 40 and 60 degrees F. That alley way of temperature where our little fishes are in the most danger of Aeromonas infections and Parasite attack.

Aeromonas become active at 42 F and remain to well above 90 degrees F. Our koi's immune system does not become effective to fight off infections until above 45 degrees F. We do not begin to feed our fish until above 50 degrees F. So, by the time our little fishes can even help themselves, those bugs are already doing the dastardly deeds. So what are we to do?

Consider these steps to reduce Aeromona loads in our ponds:

- Remember that all bacteria thrive in high (I say any) organic environment. Clean, Clean, Clean your pond. Clean the bottom, clean your streams, and clean your filters. Clean often. Don't wait until a problem pops up.
- Conduct water changes. If we conduct a 10, 20 or 30% change weekly, it stands to reason we reduce Aeromonas by that same value. (The fishes love fresh water and don't forget to dechlor).
- If possible, treat your pond with Potassium Permanganate. A therapeutic dose of 2ppm for 4-8 hours will do. (PP is very dangerous if not properly administered. Know what you are doing or <u>ask for help</u>).
- Salt to .2 .3% (after PP) for 14-21 days. This will reduce parasites. (Do this when H2O temperatures are above 45 50 degrees F, salt has a temperature lowering effect on the H2O).
- DO NOT get in a big hurry to feed when temperatures go above 50 degrees F. Food means feces. Aeromonas feed on feces. Less feces, less Aeromonas. Less Aeromonas, fewer ulcers. Get the picture? When you do feed, feed an immune system enhancing feed for the first few weeks (14-21 days). Last year our club, through Coastal Pond, acquired Romet. I hope we do it again this year.
- Use Lymnozyme above 45 degrees F. This product is a proven natural enzyme that starves aeromonas. Some people like to begin a regiment in the spring (above 45 degrees F) and again in the fall only. What ever helps.

Watch your critters for signs of problems. If a problem should arise, take the appropriate health action early. Your fishes will love you for it.
