Bakki Shower by Diane Giangrande

I am happy to say that I just had a bakki shower installed and it is up and running. So, a lot of people are probably wondering.....why a bakki shower? Well, I can tell you my reason, but first let's start with a little bit about my pond. As a lot of you know I got into the koi hobby because there was a fountain in my backyard when I bought my house in November 2011. The following January, much to my surprise, I found a goldfish in the fountain among all the leaves. When spring came I cleaned the fountain and went to Petsmart to get the goldie a friend. Then I started reading up on fish in ponds and decided to get a few koi from the now out of business Wakoola. From that point on I was hooked and shortly thereafter found the Atlanta Koi Club. In the summer of 2012 I built my first pond – it was 2500 gallons and I loved it! However, as all you koi kichi know, 2500 gallons got small really quickly. In the spring of 2015 I broke ground on the expansion and now have an 11,000 gallon pond. The original 2,500 gallon pond had a GC Tek AlphaOne 4.25 bead filter and when I expanded I added a GC Tek AlphaOne 9.3 LH bead filter. Well, I thought – wow – I have 11,000 gallons now I can add more fish. And add more fish I did lots more! As there is always something to learn in the koi hobby I am always reading about all things koi and in the course of my reading I came across bakki showers and how wonderful they are for adding biological filtration. In my set up I was relying on the bead filters to do both mechanical and biological filtration and even though I was way overrated for my size pond, I was not happy with the water. So, fast forward to this spring where I purchased a bakki shower. One of my personal pet peeves with bakki showers is that I don't like the way they look when they are sitting on the edge of the pond. In most cases this is done so the water can return to the pond via gravity. I was able to put my shower with my filters and have the water empty from the shower into a pipe that returns to a TPR on my inside pond. The media I am using in H-1 media from China. Most of it I already had in my water fall box and I just relocated it to the bakki shower. Something I learned the hard way is don't stack this media next to and on top of each other when it is fully submersed. The media

was disgusting! For the bakki shower I stacked the media perpendicular to each other being careful to leave space between each piece to allow a lot of air and hopefully not get any clogs. At the moment it's only been running a few days, but so far so good. I'm hosting the social in July so you'll be able to see my set up then.
